- We understand that we must complete and submit all information and forms deemed necessary by the After School Program for the safety and well-being of the children.
- We understand that the After School Program is an extension of the school day and have directed our child/ren to adhere to all school policies and regulations. We further understand that breaches of these rules will be cause for disciplinary action, whose implementation we will support, with all school policies as dictated in the parent/student handbook.
- We understand that students must be signed in/out of the After School Program, by the parent, guardian or authorized adult (18 years or older) indicated on the child's After School Release Form, and that students will only be released to adults authorized on the Student Release Authorization Form.
